Tuition Rates and Fees for 2025-2026

NEW STUDENT APPLICATION FEE

A fee of \$75.00 is charged with each new student application.

ENROLLMENT DEPOSIT

A one-time enrollment deposit of \$1,000.00 is required for each new student and is collected when the enrollment contract is submitted. This deposit is automatically applied to each subsequent enrollment year and is refundable upon graduation, or if you communicate with the Admissions Director your intent to disenroll your student for the following school year before the deadline of April 15 of the current school year. The enrollment deposit is not refundable for new students who withdraw within the first provisional 10 days of school.

Tuition Payment Options

Option 1 - Annual Payment Plan through FACTS

Due in full on or before July 1, 2025 (or upon enrollment if after July 1).

FACTS charges a \$25 non-refundable fee to cover billing for field trips, childcare, lunches and other charges through the year.

Tuition insurance* is recommended.

Option 2 - Monthly Payments through FACTS

FACTS charges a \$55 non-refundable fee to cover monthly payments and billing for field trips, childcare, lunches and other charges through the year.

Payments are scheduled July 2025 (or within 30 days of enrollment) through April 2026.

Tuition insurance* is required.

*The tuition insurance premium rate for the 2025-2026 school year is 1.6% of tuition after Tuition Assistance and Tuiton Grants. (Premium rate is subject to change annually.)

AUTOMATIC RENEWAL

Contracts will automatically renew under the same terms for the next academic year at the tuition and fees then in effect unless either (a) RSSAA or you as Parents/Guardians have given written notice of your intention not to renew on or prior to April 15 of the immediately preceding academic year, or (b) the student has completed Grade 12 and has successfully graduated. If you disenroll after April 15 but before September 1, you are responsible for 25% of the full year's tuition. If you disenroll your student after Sept. 1, you are responsible for 100% of the full year's tuition.

TUITION ASSISTANCE

Our school is committed to economic diversity in our student body. Our Tuition Assistance and Tuition Grant awards are based on financial need and require a completed application through FACTS. Tuition Assistance and Tuition Grants are not available to international students.

Tuition assistance is available to cover up to 75% of tuition for qualifying families. Additional tuition assistance above 75% is considered based on need.

Please visit the Admissions section of our website for application instructions. FACTS charges a \$75 per family application fee. Once your application file is complete, you are welcome to apply for a tuition assistance award. Your assistance application must be submitted within 10 calendar days of your completed application. No applications will be considered after these 10 days, and no applications will be considered once a signed contract is submitted. Our Admissions Director will let you know when an application is complete (including references and report cards received, and admissions conversation complete).

ADDITIONAL EXPENSES

There are additional expenses for field trips, instrument rentals, afterschool athletics, afterschool clubs, or occasional special events. A list of estimated additional expenses by grade is available by request.

AFTERCARE (PreK – Grade 8)

Pre-Registered Aftercare is offered after school until 5:30 pm and is charged by the hour. If registered at least 24 hours in advance, the hourly rate is \$10.00 per family (1 hour minimum invoiced). After the first hour, families are charged in one hour increments. Invoices are issued monthly, and charges are billed through FACTS.

Drop-In Aftercare (if available) is offered for \$12.00/hour <u>per family</u> (1 hour minimum invoiced). After the first hour, families are charged in one hour increments. Invoices are issued monthly, and charges are billed through FACTS.

Late Pick-Up Fees of \$1.00/minute per child are assessed for students remaining in Aftercare after 5:30 pm.
